#### LOCAL PLAN PART 1 PUBLICATION

We have now produced the final desktop published version of the adopted Local Plan 2031 Part 1.

#### AUTHORITY MONITORING REPORT

The Council has published an Authority Monitoring Report (AMR) that covers the period from 1 April 2015 to 31 March 2016.

The AMR helps to track the progress towards meeting our development needs and to establish whether our adopted policies for the Local Plan 2031 Part 1 are being effectively implemented.

#### FIVE YEAR HOUSING LAND SUPPLY UPDATE

The Council has updated its five year housing land supply position as of the 31 March 2017. The Council has a five year housing land supply of 6.7 years district wide.

#### UPDATE ON LOCAL PLAN 2031 PART 2 AND NEXT STEPS

We received over 3,000 comments from over 500 individual consultees and/or organisations to our Local Plan 2031 Part 2 Preferred Options Consultation. We are currently reviewing the consultation responses to inform an update to the Part 2 Plan. It is anticipated that we will consult on the Publication Version of the Local Plan 2031 Part 2 in the autumn of 2017.



#### DEVELOPER CONTRIBUTIONS SUPPLEMENTARY PLANNING DOCUMENT (SPD)

Alongside the Community Infrastructure Levy (CIL), we consulted on a draft Developer Contributions Supplementary Planning Document (SPD) from December 2016 to January 2017.

We are currently reviewing the consultation responses received and updating the SPD. It is anticipated the SPD will be adopted in summer 2017.

#### COMMUNITY INFRASTRUCTURE LEVY (CIL) UPDATE

The Council has received the Inspector's Final Report following the Examination of the Community Infrastructure Levy (CIL) Draft Charging Schedule.
