WHEREAS, The bloodshed we saw in El Paso and Dayton recently was not inevitable, but the price of inaction; and

WHEREAS, we must stop pretending that we are powerless to prevent these tragedies; and

WHEREAS, Republican lawmakers continue to offer ‘thoughts and prayers,’ tell us not to ‘politicize the issue,’ and say that the aftermath of a shooting is not the time to have an honest conversation about how we can end our nation’s epidemic of gun violence; and

WHEREAS, we know this because we heard them say the exact same things after Virginia Beach, Thousand Oaks, Pittsburgh, and Annapolis. They said it after Sante Fe, Sutherland Springs, and Las Vegas. They said after Orlando the first time, and Orlando the second time. They said it after Aurora in Colorado and Aurora in Illinois. They said it after Ft. Lauderdale, Burlington, San Bernardino, Roseburg, and Chattanooga. They said it after Parkland, Newtown, Virginia Tech, and Columbine; and

WHEREAS, the cruel indifference of the NRA and cowardice of Republican lawmakers must end; and

THEREFORE BE IT RESOLVED THAT, we must come together as Americans and demand action, hold our elected leaders accountable, and do everything in our power to prevent these tragedies from happening – again and again and again;

WHEREAS, Democrats recognize that climate change is a present, urgent, and growing threat to our economy, our national security, and our future; and

WHEREAS, fighting climate change is both a moral imperative and one of the biggest economic opportunities of our time; and

WHEREAS, workers, communities of color and low-income Americans suffer disproportionately from environmental degradation and climate change; and

WHEREAS, the Trump administration and many Republican lawmakers continue to roll back essential protections for our environment, climate, and public health; and

WHEREAS, Trump installed a former coal lobbyist as head of the Environmental Protection Agency; and

Resolution Urging Congress to Take Immediate Action Addressing the Climate Crisis

WHEREAS, “promoting and encouraging...the fulfillment by the Party of its platform pledge” is one of the primary responsibilities of the Democratic National Committee; and

WHEREAS, our Charter calls on the Democratic National Committee to “Work with Democratic public officials at all levels to achieve the objectives of the Democratic Party.”

WHEREAS, our party platform says that “we are committed to doing everything we can to build a full employment economy, where everyone has a job that pays enough to raise a family and live in dignity with a sense of purpose;”

WHEREAS, our platform says that “Democrats believe that climate change poses a real and urgent threat to our economy, our national security, and our children’s health and futures, and that Americans deserve the jobs and security that come from becoming the clean energy superpower of the 21st century;”

WHEREAS, our platform says that “Democrats share a deep commitment to tackling the climate challenge; creating millions of good-paying middle class jobs; reducing greenhouse gas emissions more than 80 percent below 2005 levels by 2050; and meeting the pledge President Obama put forward in the landmark Paris Agreement;”

WHEREAS, our platform says that “we will not only meet the goals we set in Paris, we will seek to exceed them and push other countries to do the same by slashing carbon pollution and rapidly driving down emissions of greenhouse gases like hydrofluorocarbons;”

WHEREAS, our platform says that “we are committed to a national mobilization, and to leading a global effort to mobilize nations to address this threat (global warming) on a scale not seen since World War II;”

WHEREAS, our platform says that “we believe America must be running entirely on clean energy by mid-century;”

WHEREAS, our platform says that “Democrats reject the notion that we have to choose between protecting our planet and creating good-paying jobs. We can and we will do both.”

WHEREAS, our platform says that “Democrats recognize the importance of climate leadership at the local level and know that achieving our national clean energy goals requires an active partnership with states, cities, and rural communities where so much of our country’s energy policy is made. We will ensure that those taking the lead on clean energy and energy efficiency have the tools and resources they need to succeed;”

WHEREAS, our platform says that “we cannot leave our children a planet that has been profoundly damaged.”

WHEREAS, responding appropriately to the climate crisis will create millions of jobs providing Americans with clean, renewable energy; upgrading the energy efficiency of existing buildings and homes; manufacturing zero-emission vehicles; constructing the infrastructure needed to support zero-emission vehicles; upgrading and constructing public transportation, including high-speed rail; planting trees; and researching and developing new clean and renewable energy technologies; and

WHEREAS, saving humanity from a horrific future and possible extinction should not be a partisan issue, but the Republican Party has made it a partisan issue, making victory for Democratic candidates up and down the ballot in upcoming elections our last best hope for averting a climate catastrophe;

THEREFORE, BE IT RESOLVED that the Democratic National Committee commends the Democratic House of Representatives for putting forward legislation that is essential to fulfilling pledges in our platform by promoting more jobs for Americans and taking immediate action in response to the climate crisis;

BE IT FURTHER RESOLVED that the Democratic National Committee encourages Democrats in state legislatures, and local government offices to enact state and local provisions expanding employment for their constituents and responding appropriately to the climate crisis; and

BE IT FURTHER RESOLVED that the Democratic National Committee encourages Democrats in states with the initiative to draft, submit, and support ballot proposals that expand employment and respond appropriately to the climate crisis; and will ensure that local efforts have the tools and resources they need to succeed.

Resolution Reaffirming The Democratic Party's Commitment To Making Climate Change A Central Issue In The 2020 Presidential Primary

WHEREAS, climate change poses an existential threat to our planet and must be treated with such urgency; and

WHEREAS, climate change has too often been thought of as an isolated issue or simply a matter of environmental policy; in reality, climate change has wide ranging impacts on our economy, income inequality, racial equity, the health of our families, infrastructure, agricultural systems and food supply, housing, national security, and social justice, among many issues; and

WHEREAS, the Republican Party, led by President Trump, continues to willfully ignore the urgent threat that climate change poses to our way of life by denying overwhelming scientific

evidence and putting the interests of polluters ahead of our children's health and the very future of all mankind; and

WHEREAS, the willful disregard of Republican leaders on Capitol Hill and in state legislatures across the country has been on full display in recent weeks; President Trump claimed that climate change happens "both ways," the Vice President refused to acknowledge the existence of the threat climate change poses, and the Trump administration was revealed to have buried scientific reports on the dangers of climate change; and

WHEREAS, these events serve as poignant reminders that the future of our planet is at stake in the upcoming presidential election; and

WHEREAS, the Democratic Party and its candidates are unified in their belief that climate change is real and must be treated as a clear and present danger by our next president; and

WHEREAS, after climate change was too often ignored as a major issue during the 2016 Democratic primary and received virtually no attention during the debates, the DNC and Chair Tom Perez resolved to make sure that climate change was featured prominently during the 2020 primary process; and

WHEREAS, for two years, the DNC has made clear to its debate media partners – including by the Chair of the Democratic Party himself – that climate change must be treated as a major issue with broad implications for American voters during the 2020 primary debates; and

WHEREAS, in order to meet its obligation to be neutral in the Democratic primary process, the DNC concluded that it should not hold debates devoted to one specific topics, nor can it agree to requests for such debates by individual presidential candidates; and

WHEREAS, the DNC has applied this standard in turning down dozens of requests for issue-specific debates from individuals and organizations, including those asking for a climate-specific debate; and

WHEREAS, climate issues should be debated amongst candidates throughout our primary process, not just at one debate; and

WHEREAS, the DNC has repeatedly encouraged candidates to participate in issue-specific forums, which have a long history of providing the best venue for in-depth conversations on specific policy matters; and

WHEREAS, the DNC wholly supports and encourages candidate participation in forums focused on climate change, and believes these events are critical to elevating the issue during a primary process;

THEREFORE, BE IT RESOLVED, that the DNC reaffirms its commitment to ensuring that climate change is a central issue in the 2020 primary process and will continue to insist that its media partners dedicate an appropriate amount of time to climate issues in the cycle's primary debates; and

BE IT ALSO RESOLVED, that the DNC strongly encourages Democratic presidential candidates to participate in climate and other issue forums, and believes that such events play an indispensable role in the primary process; and

BE IT ALSO RESOLVED, that the DNC calls on its partners and organizations to organize climate-specific forums and invite all candidates to attend and speak at such forums.

WHEREAS, Climate Change impacts everyone on our planet, exacerbating economic instability, causing irreversible damage to our biodiversity, and disproportionately impacting vulnerable populations globally; and,

WHEREAS, as Democrats we both believe in science and in acting now to prevent further damage to our people, planet and economies; and

WHEREAS, failure to address Climate Change comprehensively now may result in creating only temporary and partial solutions to the fundamental inequities in American society that are the core of the Democratic platform; and

THEREFORE, BE IT FURTHER RESOLVED, that if the DNC decides not to sponsor such a debate that it clearly states that our candidates are free to participate in any and all forums or debates focused on Climate Change sponsored by other groups.

Resolution Calling on the DNC to Hold a Climate Focused Debate in the Pacific Northwest

WHEREAS, we the people of planet earth have less than 12 years to reverse the effects of climate change¹; and

WHEREAS, the climate crisis is our number one threat to national security²; and

WHEREAS, climate change is the number one issue among Democratic primary voters³; and

WHEREAS, the Democratic Party Platform states, “Climate change is an urgent threat and a defining challenge of our time.”; and

WHEREAS, the Democratic Party Platform recognizes that “California and the West have suffered years of brutal drought. Alaska has been scorched by wildfire.”; and

WHEREAS, the Democratic Party Platform states “We will take bold steps to slash carbon pollution and protect clean air at home, lead the fight against climate change around the world, ensure no Americans are left out or left behind as we accelerate the transition to a clean energy economy, and be responsible stewards of our natural resources and our public lands and waters”; and

WHEREAS, the Democratic Party Platform states “Democrats share a deep commitment to tackling the climate challenge; creating millions of good-paying middle class jobs; reducing greenhouse gas emissions more than 80 percent below 2005 levels by 2050; and meeting the pledge President Obama put forward in the landmark Paris Agreement, which aims to keep global temperature increases to “well below” two degrees Celsius and to pursue efforts to limit global temperature increases to 1.5 degrees Celsius.”; and

WHEREAS, the 2016 Democratic Party Platform states “We are committed to getting 50 percent of our electricity from clean energy sources within a decade, with half a billion solar panels installed within four years and enough renewable energy to power every home in the country.”; and

WHEREAS, the 2016 Democratic Party Platform recognizes environmental racism in stating “The impacts of climate change will also disproportionately affect low-income and minority communities, tribal nations, and Alaska Native villages—all of which suffer the worst losses during extreme weather and have the fewest resources to prepare.”; and

WHEREAS, both the DNC and other major organizers have not held climate focused debates during previous presidential primaries⁴; and

WHEREAS, climate debates provide valuable education opportunities for voters, and demonstrate that a candidate is prepared to present policies that will combat greenhouse gas emissions and negate the effects of the climate crisis; and

WHEREAS, the DNC has notified candidates that the DNC would not host a climate focused debate; and

WHEREAS, the DNC has notified candidates that they may not participate in a non-DNC debate, or they would be prohibited from participating in future DNC debates; and

WHEREAS, the glaciers in the Cascade Mountains, Sierra Nevada Mountains and Alaska are quickly disappearing due to increasing temperatures; and

WHEREAS, the waterways in the Pacific Northwest are warming to the point where Pacific Salmon will no longer be able to survive and thrive; and

WHEREAS, snowpack, the source of fresh water for much of the Pacific Northwest is decreasing due to increasing temperatures; and

WHEREAS, forest fires in the Pacific Northwest are increasing with alarming intensity and frequency, often resulting in dangerous smoke and dangerous summertime air quality; and

WHEREAS, west coast states are national leaders in environmental sustainability;

THEREFORE, BE IT RESOLVED, that the DNC will either host a climate change debate in the Pacific Northwest in which all 2020 Democratic Presidential candidates may participate and/or the DNC will change its policy to allow 2020 Democratic Presidential candidates to participate in non-DNC climate focused debates without fear of being excluded from future DNC debates.

Resolution on Creating Family Wage Jobs in the Clean Energy Economy

WHEREAS, with an abundant supply of skilled workers and advanced technology, the United States is poised to take a critical role in the global clean energy movement; and

WHEREAS, the American workforce can advance the goals of the new energy economy while increasing U.S. competitiveness; and

WHEREAS, American policy should support the creation of innovation in the clean energy sector and ensure that the jobs in those industries are high-quality, safe, living-wage, family-supporting, union jobs; and

WHEREAS, the American Council for an Energy Efficient Economy estimates that every \$1 million invested in energy efficiency supports approximately 20 jobs in the construction industry; and

WHEREAS, high-quality domestic jobs would be created by putting people to work retrofitting manufacturing facilities to be more energy efficient; and

WHEREAS, retrofitting work can't be outsourced and more than 90% of the materials used are made in the United States, energy efficiency investments help to grow American jobs and the economy; and

WHEREAS, growing interest and investment in clean energy has led to a boom of new employment opportunities in the sector; but without adequate regulation to ensure job quality, these occupations may result in low-quality seasonal and short-term jobs;¹ and

WHEREAS, along with providing fair wages, benefits, and overtime pay, project labor agreements provide contractors with skilled and reliable workers, ensure projects are finished in a timely manner, and provide workers with a safe work environment; and

WHEREAS, the federal Davis-Bacon Act – along with its state and local counterparts — also helps keep construction jobs as good paying, family-supporting positions and maintain high standards in the industry by requiring contractors receiving public funds to pay the local prevailing wage; and

WHEREAS, North America’s Building Trades Unions’ U.S. Department of Labor-registered apprenticeship programs train workers to become highly-skilled construction workers, investing \$1.6 billion annually. If this system were a college or university, it would be the largest degree-granting college or university in the United States; and

WHEREAS, U.S. apprenticeships have grown 56% since 2013 with over 585,000 apprentices enrolled in training programs² who will soon be actively looking for gainful employment; and

WHEREAS, with measures to prevent a drop in occupational quality, the clean energy economy can provide benefits to communities most heavily impacted by the transition from fossil fuel industries as well as frontline communities;³

WHEREAS, the United States hosts an independent workforce of 41 million and the IRS estimates that more than 3 million of these workers are misclassified by their employers every year with 10-20% misclassifying at least one employee as an independent contractor;⁴ and

WHEREAS, the union membership rate in 2018 was 10.5% with 14.7 million Americans involved in organized labor and utilizing collective bargaining for their wages; and

THEREFORE BE IT RESOLVED that the DNC supports policy that would drive development of American clean energy infrastructure and technology by considering labor standards in loan guarantees through federal agencies, including the U.S. Department of Energy and U.S. Department of Transportation.

THEREFORE, BE IT ALSO RESOLVED THAT, the DNC urges that all federal incentives for the green economy should require Made in America provisions and labor standards, including project labor agreements, prevailing wage laws, and the use of labor from federally recognized registered apprenticeship programs.

Resolution on Moving Green Energy Across America

WHEREAS, the United States is fortunate to have abundant natural resources of wind and sunshine, which are increasingly being harnessed as integral sources of renewable energy; and

WHEREAS, wind turbines and solar arrays are not always situated in the high-population areas that consume the most energy, precipitating the need for long-distance, high-voltage electricity transmission lines; and

WHEREAS, the United States is constrained by a lack of transmission infrastructure, as meaningful upgrades to create a strong grid have not been made in the past 50 years; and

WHEREAS, the United States cannot meet its greenhouse gas emission reduction goals without modernizing its electrical grid and building additional transmission lines to deliver zero carbon hydro-, wind- and solar-generated electricity from rural areas to population centers; and

WHEREAS, a nationwide assessment found that “\$30–90 billion dollars of incremental transmission investments will be necessary in the U.S. by 2030 to meet the changing needs of the system due to electrification, with an additional \$200–600 billion needed from 2030 to 2050. These investments will be in addition to the investments needed to maintain the existing transmission system and to integrate renewable generation built to meet existing load.”⁵; and

WHEREAS, grid infrastructure projects are extremely long-lived assets that will generate tax benefits for the public for more than 50 years. They also enable increased private investments in power generation by connecting producers to markets; and

WHEREAS, one of the best ways to promote rural economic development is to build the delivery capacity to move rural energy to market. Electric transmission lines have enabled job growth, preservation of rural communities and a growing tax base across the country; and

WHEREAS, transmission is generally privately financed, and Congress has provided support to private developers investing in assets that are highly valuable to the country through tax investment incentives. Such an investment tax credit would encourage private investment and lead to increased government revenues from taxes on additional income and profits generated; and

WHEREAS, the construction of high-voltage transmission lines is planned and paid for by customers through a regulatory process. The Federal Energy Regulatory Commission could facilitate the development of interregional transmission planning practices for the approval of broadly beneficial projects, as these lines are subject to multiple, inconsistent evaluations at the regional level; and

WHEREAS, the construction of transmission lines critical to delivering electricity to population centers across state boundaries has been stymied by a state-versus-state permitting process in which one state's refusal to approve can halt critical projects.

THEREFORE, BE IT RESOLVED that the DNC commits to the promotion of policies and regulations that would prioritize the permitting and construction of transmission lines in the national interest of reduced carbon energy, security, job creation and economic development.

Resolution on a New Social Contract for Long-Term Care

WHEREAS, millions of children, adults and the elderly who have long-term physical and mental disabilities require substantial assistance in order to perform basic activities of daily living; and

WHEREAS, we tend to take for granted our ability to perform daily activities such as bathing, grooming, eating and toileting, as well as our ability to communicate, transport ourselves, prepare meals, shop, do housework, manage medications and personal finances, and perform all the other functions of independent living; and

WHEREAS, for millions of Americans and people of all ages with chronic illness or disability, these activities require varying degrees of assistance from a paid caregiver or unpaid friend or family member, either at home or in an institutional setting; and

WHEREAS, most Americans of working age who live with disabilities yearn to be independent and productive -- contributing to the economy and society -- but lack access to adequate attendant care that would make these beneficial outcomes possible; and

WHEREAS, coping with chronic illness and disability is hard enough for individuals and their families, but most also face financial catastrophe due to the punishingly high cost of long-term care, which can be exacerbated by the inability of many overburdened family caregivers to participate in the paid labor force; and

WHEREAS, the cost of home care -- including home health aides, durable medical equipment, accessible ramp vans, medical supplies, medical transportation, drugs, doctor visits, physical/occupational/ speech therapy, and insurance premiums -- can often exceed household income, while the annual cost of care in a nursing facility currently averages over \$80,000 nationwide, and

WHEREAS, Medicare essentially covers acute care services and specifically excludes coverage for most long-term services and supports, as do most individual- and employer-paid health insurance policies; and

WHEREAS, private long-term care insurance policies are too expensive for most people to purchase, are riddled with exclusions and limitations, are not designed to cover children who are born with disabilities, and typically cannot be purchased at any price by those with “preexisting conditions” because these plans are excluded from Affordable Care Act protections; and

WHEREAS, most people don’t have incomes and assets low enough to qualify for Medicaid -- the nation’s health insurance system for low-income Americans AND our principal long-term care social safety net program -- but can eventually qualify for Medicaid’s long term care coverage if they deplete their life’s savings and impoverish themselves paying for care; and

WHEREAS, the heavy burden on family caregivers causes well-documented burnout, isolation, stress and financial devastation, while the value of uncompensated caregiving for adult family members was estimated recently to be more than double the amount spent on paid long-term caregiving of adults by all payers, public and private; and

WHEREAS, Americans urgently require a new social contract that guarantees high-quality long-term care to all who need it, prevents impoverishment, ensures that people with disabilities have the option to live independently and contribute to the economy while receiving care and assistance, and does not force family members to choose between earning a living and caring for loved ones; and

WHEREAS, universal social insurance – based on pooled resources in the manner of Social Security and Medicare -- is the most practical way to protect the U.S. population against the universal risk of needing long term care, has been adopted successfully in other wealthy countries such as Germany/Japan/Sweden, is affordable, has no means-test, is sound and has not resulted in bankruptcy for any country that has adopted such a system; and

WHEREAS, those who erroneously claim the U.S. can’t afford a new social insurance system fail to grasp that we are all vulnerable to the risk of chronic illness and disability, but that only the richest individuals and families can afford to pay for long-term care;

THEREFORE, BE IT RESOLVED THAT, the National Democratic Seniors Coordinating Council of the DNC believes that the time to address the overwhelming burdens associated with the costs of long-term services and supports is long overdue in the U.S. and that the only practical solution is a universal, comprehensive, affordable, non-means-tested social insurance system covering high quality long-term care -- both at home and in institutional settings; and

THEREFORE, BE IT ALSO RESOLVED, THAT the NDSCC recommends to the full DNC and to Democratic Members of Congress that NOW is the time to place such a long-term care insurance system high on the party agenda, introduce Congressional legislation and build a national movement to ensure its enactment.

Resolution Supporting the U.S. House of Representatives as they Exercise their Constitutional Responsibility with Oversight Inquiries into President Donald J. Trump

WHEREAS, President Donald Trump faces at least 14 ongoing criminal or civil inquiries by federal, state, and city agencies into himself and nearly everything he has ever run; and

WHEREAS, experts on both sides of the aisle have considered both the extent of possible wrongdoing and the extent of probes into President Donald Trump to be unprecedented; and

WHEREAS, current probes into President Donald Trump number five probes related to his 2016 campaign and 2017 inauguration; eight probes related to his company and personal finances; and one probe into his explicit personal conduct; and

WHEREAS, in addition to ongoing federal, state, and city inquiries, Special Counsel Mueller recently released a Report on the Investigation into Russian Interference in the 2016 Presidential Election (“the Mueller Report”) finding that, “The Russian government interfered in the 2016 presidential election in sweeping and systematic fashion” which included hacking the Democratic National Committee; and

WHEREAS, at the conclusion of Special Counsel Mueller’s May 29, 2019 press conference, he said, “I will close by reiterating the central allegation of our indictments: That there were multiple, systematic efforts to interfere in our election, and that allegation deserves the attention of every American”; and

WHEREAS, Robert Mueller testified before the House Intelligence Committee on July 24, 2019 that Russians will try to be involved in our next election, saying they are “doing it as we sit here, and they expect to do it during the next election.”

WHEREAS, Volume II of the Mueller Report began “Beginning in 2017, the President of the United States took a variety of actions towards the ongoing FBI investigation into Russia’s interference in the 2016 presidential election and related matters that raised questions about whether he had obstructed justice”; and

WHEREAS, the Mueller Report went on to describe multiple obstructive events including one on June 19, 2017, when Trump directed his former campaign manager, Corey Lewandowski, to deliver a message to then-Attorney General Jeff Sessions, directing Mr. Sessions to give a speech publicly announcing he would revoke his recusal over the Office of Special Counsel’s investigation into Russian interference, and limit the Office’s jurisdiction exclusively to “future elections,” which would have prevented any further inquiry into Russian interference in the 2016 election; and

WHEREAS, when Mueller testified before the Judiciary Committee on July 24, 2019 he said “I would generally agree with that” when asked if his investigation was impeded by Trump campaign and administration officials; and

WHEREAS, Mueller’s investigation resulted in: the filing of nearly 200 criminal charges against 34 people and three companies; seven guilty pleas; 25 ongoing criminal cases and 14 criminal referrals; and \$40 million of cash and assets recovered by the US government by wrongdoers found guilty of crimes ranging from money laundering to conspiracy against the United States of America; and

WHEREAS, in a sentencing memo of Michael Cohen, the Southern District of New York directly implicated President Donald Trump in a crime that Michael Cohen is currently serving time in prison for, writing that Michael Cohen “acted in coordination and at the direction of” President Donald Trump; and

WHEREAS, page 1 of Volume II of the Mueller Report notes why no traditional prosecution decision was made by Mueller, or by the Southern District of New York: “[A] traditional prosecution or declination decision entails a binary determination to initiate or decline a prosecution, but we determined not to make a traditional prosecutorial judgment. The Office of Legal Counsel (OLC) has issued an opinion finding that [‘]the indictment or criminal prosecution of a sitting President would impermissibly undermine the capacity of the executive branch to perform its constitutionally assigned functions[‘] in violation of [‘]the constitutional separation of powers.[‘] Given the role of the Special Counsel as an attorney in the Department of Justice and the framework of the Special Counsel regulations [internal citation omitted] this Office accepted OLC’s legal conclusion for the purpose of exercising prosecutorial jurisdiction”; and

WHEREAS, in Special Counsel Mueller’s May 29, 2019 press conference announcing the closure of his Office, he said, in citing the OLC’s opinion: “the [OLC] opinion explicitly permits the investigation of a sitting president because it is important to preserve evidence while memories are fresh and documents available” but also added, “the [OLC] opinion says that the Constitution requires a process other than the criminal justice system to formally accuse a sitting president of wrongdoing”; and

WHEREAS, the U.S. Constitution grants the Congress implicit authority to investigate the executive via an array of enumerated powers; and,

WHEREAS, the U.S. Supreme Court has affirmed Congress’ vast power to investigate the executive via their 1927 decision in *McGrain v. Daugherty* that by investigating the administration, Congress was considering a subject “on which legislation could be had or would be materially aided by the information which the investigation was calculated to elicit”; and

THEREFORE BE IT RESOLVED, that, given the nature of our constitutional system of government, the U.S. Congress has the responsibility to conduct oversight and thorough inquiries of the actions of the President of the United States in order to ensure the safety, sovereignty and wellbeing of all Americans;

BE IT FURTHER RESOLVED, that the U.S. House Of Representatives must continue and accelerate its thorough inquiries into President Donald Trump, particularly via the Committees on the Judiciary, Oversight, Ways and Means, Financial Services, Foreign Relations and Intelligence;

BE IT FURTHER RESOLVED, inquiries into President Donald Trump should investigate, among other matters: whether the President sought to obstruct investigations into himself, his 2016 campaign, and his campaign’s associates; whether the President sought to obstruct investigations into Russian interference in the 2016 elections itself; whether the President is liable for other crimes committed during the 2016 election; whether the President is compromised in any form due to his involvement in Russian interference in the 2016 elections, his involvement in obstruction of investigations into that interference, or his involvement in other crimes committed during the 2016 election.

BE IT FURTHER RESOLVED, that if in fact evidence from the pre-Impeachment inquiries is deemed sufficient by the U.S. House of Representatives to conduct an Impeachment inquiry, that the decision on Impeaching the President will be conducted without regard to its political ramifications and without regard to the prospects for the removal of Donald J. Trump from the office of President of the United States if the U.S. Senate chooses not to convict and remove Donald J. Trump from the Office of the President.

Resolution on the Right to Organize

WHEREAS, the National Labor Relations Act (NLRA) of 1935 was a victory for labor unions and collective bargaining rights. The NLRA, which provides workers the right to join unions and collectively bargain for wages and benefits, is the cornerstone of workers' rights in the United States and produced a thriving middle class in the post-World War II era; and

WHEREAS, collective bargaining ensures workers have fair wages, job security, adequate health care, retirement security and a fair process to address their concerns. When unions are strong, these benefits spill over into other nonunion workplaces; and

WHEREAS, workers who belong to unions are more likely to have retirement benefits, healthcare benefits and paid vacations; and

WHEREAS, while the wealthiest 1 percent of Americans have captured 70 percent of the economic growth over the past 40 years, the middle class has been left behind⁶; and

WHEREAS, with this increased concentration of income, the wealthy are able to play an outsized role in politics, shaping government policy to help themselves instead of the population at large. As of 2019, twenty-seven states in the U.S. have enacted right-to-work laws that have significantly hurt labor unions; and

WHEREAS, the decline in union membership over the past 30 years parallels the shrinking middle class, which has been plagued by stagnant wages, higher household debt and nagging income inequality; and

WHEREAS, union membership raises wages for non-college graduates, people of color, millennials, women and workers in general; and

WHEREAS, being in a union not only helps wage earners, but their children, as a parent's union membership is associated with higher future wages for one's children, especially for kids whose parents do not have a college education, further boosting intergenerational mobility. Indeed, American children of non-college-educated parents earn 28 percent more as adults if their parent was in a labor union compared to children in similar families but whose parent was not in a union⁷; and

WHEREAS, among the lowest-wage workers, a union contract raises wages by more than 20 percent. In the United States and across the globe, researchers have found that working people in highly unionized areas are less likely to live in poverty⁸; and

WHEREAS, unions provide a kind of social capital for workers and encourage workers—especially those with lower incomes and less education—to join other organizations, especially political organizations, which can boost their sense of agency. This combination of factors may help explain why unions have a positive impact on workers' health and general sense of well-being⁹; and

WHEREAS, despite the current administration's pledge to protect American workers, many actions by this administration have severely hurt workers' rights and labor unions; and

WHEREAS, the Protecting the Right to Organize (PRO) Act of 2019 would help labor unions by protecting workers' rights to organize and bargain collectively for adequate wages and benefits, strengthening the NLRA-guaranteed rights that have been so severely weakened that employers routinely ignore them; and

WHEREAS, the PRO Act would establish penalties on corporations that would violate workers' rights, allow employees to have more freedom to organize without interference as well as protect workers' rights to strike and bargain collectively¹⁰; and

Resolution in Support of Federal Workers' Collective Bargaining Rights

WHEREAS, the Civil Service Reform Act of 1978 codified collective bargaining rights for federal employees and included in the law language describing collective bargaining for federal employees as “safeguard[ing] the public interest;” and

WHEREAS, the law requires federal agencies and federal employee unions to bargain in good faith over a grievance and arbitration procedure, and the conditions of employment; and

WHEREAS, federal employee unions are required by this law to represent all members of the bargaining unit, whether they join the union and pay dues or not; federal employee unions are not permitted to bargain over pay or benefits; and

WHEREAS, federal workers are solidly middle class and perform a broad variety of functions on behalf of the American people, including caring for our nation’s veterans; providing civilian support to our military; protecting the safety of our air, food and water; securing our borders, airports and federal buildings; providing the elderly and disabled with Social Security benefits and services; preserving our nation’s national landmarks and national parks; and protecting our communities from dangerous criminals incarcerated in our federal prisons; and

WHEREAS, federal employees demonstrate their profound dedication to serving the American public, and as such, the government should protect, not undermine, their rights in the workplace, including their right to union representation and collective bargaining; and

WHEREAS, the federal agencies are not meeting their legal obligations to bargain in good faith; and

WHEREAS, the collective bargaining rights of federal workers are under attack through the imposition of contracts designed to eliminate federal employees’ representation rights and the ability of their unions to provide member representation in the workplace; and

WHEREAS, anti-democratic and anti-worker “agreements” that all but prevent the ability of federal unions to represent the members of their bargaining units are being unilaterally imposed upon federal workers; and

WHEREAS, these unilaterally imposed “contracts” remove the union from the federal workplace—allowing no space for the union to conduct specific representational duties as required by federal law; and

WHEREAS, attacks on federal workers’ collective bargaining rights at federal agencies are inhibiting constructive, collaborative labor-management relationships which help facilitate a better, safer, more productive workforce and that have proven successful in preventing workplace discrimination, promoting a healthy and safe work environment, and preventing retaliation against whistleblowers; and

WHEREAS, federal workers deserve fair and genuine collective bargaining and representation free of any political agenda; and

WHEREAS, the right for federal workers to choose payroll deduction for their union dues is being threatened in such a way as to intimidate federal workers and infringe on their ability to choose to join a union, with the clear goal of decreasing union membership; and

WHEREAS, federal employee unions help protect the apolitical, professional civil service, and ensure high quality and apolitical provision of vital services to the American public; and

WHEREAS, allowing any employer, especially the federal government, to defy laws establishing the right for workers to democratically form and join unions as a means to achieve political objectives undermines the rule of law and the existence of a free, independent labor movement in our country; and

WHEREAS, the Democratic Party has a long and proud history of steadfast support for labor unions and the institution of collective bargaining and its platform reflects this ongoing support; thus, all efforts to erode unions is an attack on democracy, the right to bargain for decent working conditions, job security, and fair treatment on the job;

THEREFORE, BE IT RESOLVED, that the Democratic National Committee calls on Congress and the President to publicly recognize the rights of federal employees and take action to uphold the collective bargaining rights of federal workers and ensure that all federal agencies meet the legal obligation to bargain in good faith with federal employee unions.

Resolution Calling for No Vote until the USMCA is Fixed

WHEREAS, for over two and a half decades the North American Free Trade Agreement (NAFTA) has devastated American workers and their communities; and

WHEREAS, between 1993-2013, over 850,000 U.S. jobs were lost due to outsourcing to Mexico, with manufacturing workers bearing the brunt of the impact; and

WHEREAS, between 1993-2016, the U.S.-Mexico auto trade deficit grew 1288%, and the auto parts deficit exploded by 23,700%, and over the same period, the U.S. lost ten final auto assembly plants, while Mexico gained eight; and

WHEREAS, over the past twenty-five years wages for U.S. manufacturing workers have largely failed to keep up with the rising cost of living despite improvements in worker productivity; and

WHEREAS, as it stands today the U.S., Mexico, and Canada Agreement (USMCA) will not prevent multinational corporations from outsourcing jobs to Mexico where workers often earn \$2 or \$3 an hour; and

WHEREAS, USMCA renegotiation provides us with an opportunity to raise wages and strengthen benefits for manufacturing workers, and trade negotiators and Congress need to make the agreement good for workers, as the labor standards lack credible enforcement mechanisms; and

WHEREAS, more changes are needed in the text of the agreement if it is to curtail factories moving from the U.S. to Mexico, and we need to move beyond the status quo and enact a trade agreement that fundamentally transforms the lives of working families; and

WHEREAS, more work needs to be done on USMCA in order to protect and enhance opportunities for the U.S. workforce, leading to higher wages and benefits for manufacturing workers; and

WHEREAS, we need to make sure Mexico implements labor laws and ends protection contracts prior to entering into any new agreement to make sure the USMCA works in the short term and 10 years from now; and

WHEREAS, we need stronger enforcement mechanisms that impose economic penalties on companies for worker's rights abuses in Mexico, and it is important that they implement the changes and establish the legal infrastructure so workers can join real unions; and

WHEREAS, the current NAFTA agreement allows drug manufacturers the ability to exclusively produce patented drugs for 10 years and advocates have sought to drastically reduce the period of exclusivity because it could lead to lower drug prices for consumers; and

WHEREAS, USMCA should be amended to increase competition and improve patient access to affordable prescription drugs;

THEREFORE, BE IT RESOLVED, that the Democratic National Committee call on the Administration and Congress to not ratify the renegotiated NAFTA, known as the USMCA, and that there should be no vote until it's fixed.

Resolution Urging Full Access and Inclusion for Persons With Disabilities in the Democratic Party

WHEREAS, 2019 marks the 29th anniversary of the signing of the Americans with Disabilities Act, which protects the civil and accessibility rights of disabled Americans, including ballot access and voting rights; and,

WHEREAS, a Rutgers University study on 2012 election turnout by disabled voters reported that one-third of disabled voters had encountered barriers to voting more than three times than non-disabled voters, and the 2016 General Accountability Office election survey found that 60% of polling places were inaccessible; and,

WHEREAS, Americans with disabilities are 26% of the population according to the Centers for Disease Control and are a part of more than half of all voting families; and,

WHEREAS, voters with disabilities increased their turnout by 8.5% in 2018 - helping drive Democratic success at the polls and efforts to protect our health care - and have consistently been the second-largest minority voting block for at least a decade according to research completed by the Rutgers University School of Labor and Business Management; and,

WHEREAS, the 2016 Democratic Party Platform mentions proactive policy for access and inclusion for persons with disabilities more than two dozen times, including employment, healthcare, civil rights, housing, Social Security, Medicare, Medicaid, voting rights, and protections; and

WHEREAS, it is critically important for Democrats to lead with our values, including our belief in full access and inclusion for persons with disabilities,

THEREFORE, BE IT RESOLVED, that the Democratic National Committee (DNC) commits to conducting an accessible 2020 Democratic National Convention that lives up to the highest goals for access and inclusion of the Americans with Disabilities Act; and,

BE IT ALSO BE RESOLVED, that the DNC will provide accessible accommodations for disabled delegates and party leadership for all aspects of the 2020 Democratic National Convention, including adequate and integrated accessible seating configurations within all delegations; and,

BE IT FURTHER RESOLVED, that the DNC will ensure quality communication access accommodations for all Deaf and Hard of Hearing participants at the 2020 Democratic National Convention, providing American Sign Language and CART Live Captioning that is integral and meets the communication needs of these delegates and party leaders; and,

BE IT ALSO RESOLVED, that that the DNC will provide accessible websites, social media platforms, and materials - and commit to maintaining their accessibility in all political, fundraising, and general outreach mechanisms; and,

BE IT ALSO RESOLVED, that the DNC will seek disabled students and job seekers to apply for paid internships and employment opportunities at the DNC; and

BE IT ALSO RESOLVED, that the DNC will neither seek nor accept donations or in-kind support from any company that uses the Fair Standards Labor Act Section 14c certificate or engages in the practice of paying disabled workers sub-minimum wage; and

BE IT ALSO RESOLVED, that the DNC will conduct an internal accessibility audit every two years in preparation for each midterm and presidential election cycle; and,

BE IT ALSO RESOLVED, that the DNC will, as part of its commitment to a fair and transparent presidential nomination process, work with and encourage the news networks hosting presidential primary debates to provide communication access accommodations for both onsite in-person and broadcast for home viewers, including American Sign Language and CART live captioning that is integral and viewable without segregation; and,

BE IT ALSO RESOLVED, that the DNC encourages all presidential candidates to lead by example by ensuring their campaigns are accessible to voters, volunteers, interns, and staff with disabilities; to ensure their voter outreach efforts are accessible, including all websites, social media platforms, field offices, large events and rallies, and communications; to engage people with disabilities directly to help them form their platforms and vision for disability engagement, including advice on the accessibility of their campaigns; and, to neither seek nor accept donations or in-kind support at all from any company that uses the Fair Standards Labor Act Section 14c certificate or engages in the practice of paying disabled workers sub-minimum wage; and

BE IT ALSO RESOLVED, that copies of this Resolution Urging Full Access and Inclusion in the Democratic Party will be shared with the Democratic presidential candidates for their immediate implementation.

Resolution to Support Reforms that Expand Democracy

WHEREAS, the bylaws of our party state that “promoting and encouraging...the fulfillment by the party of its platform pledge” is one of the primary responsibilities of the Democratic National Committee and its members; and

WHEREAS, our charter calls on the Democratic Party, as represented between National Conventions by the Democratic National Committee, to “work with Democratic public officials at all levels to achieve the objectives of the Democratic Party.”

WHEREAS, our party platform states that “the Democratic Party was founded on the promise of an expanded democracy;”

WHEREAS, our platform says that “our vision for American democracy is a nation in which all people, regardless of their income, can participate in the political process and can run for office without needing to depend on large contributions from the wealthy and the powerful;” and

WHEREAS, our platform says that “we need to amplify the voices of the American people through a small donor matching public financing system.”

WHEREAS, our current system violates the most basic principle of representative democracy by leaving voters who voted for a losing candidate unrepresented;

WHEREAS, research has shown that proportional representation is a more genuinely democratic system; and

WHEREAS, the benefits to be gained through an ordered-party list system of proportional representation are not theoretical, since such systems are in place in more than 85 countries.

WHEREAS, our platform states that “we will bring our democracy into the 21st century by...ending partisan and racial gerrymandering;” and

WHEREAS, research has shown that gerrymandering is effectively eliminated in legislative bodies consisting of at least five members per district elected through an ordered-party list system of proportional representation.

WHEREAS, our platform states that “it is a core principle of the Democratic Party to maximize voter participation for all Americans;”

WHEREAS, our platform states that “our democracy suffers when nearly two thirds of our citizens do not or cannot participate;”

WHEREAS, levels of voter participation are significantly higher in countries with proportional representation; and

WHEREAS, the right to vote is more meaningful when every significant group of like-minded voters is represented in a legislative body in proportion to the percentage of the electorate represented by each group.

WHEREAS, shifting the focus to issues and party platforms in general elections by utilizing an order-party list system of proportional representation for legislative bodies greatly reduces the need for candidates to raise large sums of money to finance a campaign;

WHEREAS, women continue to be under-represented in Congress and state legislatures; and women are represented in significantly greater numbers in legislatures elected by means of an order-party list system of proportional representation;

WHEREAS, our platform states that “Democrats believe we must fight to preserve the essence of the longest standing democracy in the world: a government that represents the American people, not just a handful of powerful and wealthy special interests” and

WHEREAS, our platform states that “Democrats support a constitutional amendment to overturn the Supreme Court’s decisions in *Citizens United v. FEC* and *Buckley v. Valeo*.”

WHEREAS, the undemocratic nature of the electoral college has been made clear by the candidate with the greatest number of popular votes being denied election in two of the past five presidential elections; and

WHEREAS, ranked-choice voting ensures that the winning candidate has received the support of a majority of those casting ballots.

THEREFORE, BE IT RESOLVED, that the Democratic National Committee encourages Democrats in Congress and state legislatures and members of the Democratic Party to support legislation that would provide a public financing option for candidates for office and proportional representation and ranked-choice voting in elections where appropriate; and

BE IT FURTHER RESOLVED, that the Democratic National Committee encourages Democrats in Congress and state legislatures and members of the Democratic Party to support amendments to the Constitution of the United States that make it clear that corporations are not people and can be prohibited from using corporate funds to contribute to political campaigns or attempt to influence public policy and for direct election of the president using ranked-choice voting.

WHEREAS, when our platform pledge is fulfilled, it will lead to a better, brighter future for the people of our country and the world;

WHEREAS, our platform does not get nearly as much attention as it deserves;

Resolution to Facilitate Discussion of Our Platform Among the Candidates for Our Presidential Nomination

WHEREAS, a party platform, especially for a party as inclusive as the Democratic Party, incorporates the priorities of diverse constituencies and represents the consensus needed to promote unity within our party and serve as a solid foundation for getting our candidates elected; and

WHEREAS, our platform does not get nearly as much attention as it should; and

WHEREAS, polls consistently show that a solid majority of voters, including two-thirds of independent voters and half of Republican voters support the legislation called for in our platform; and

WHEREAS, educating voters with regard to the pragmatic proposals in our platform for addressing the problems we face as a nation will increase support for our candidates and help us win elections, making it possible to enact the legislation called for in our platform; and

WHEREAS, the technology exists to facilitate a constructive discussion without a moderator, with candidates being allotted an equal amount of time to speak during the discussion, and with the amount of time each candidate has spoken and the order in which candidates will speak monitored and controlled without interrupting the discussion.

THEREFORE, BE IT RESOLVED, that Democratic National Committee members encourage candidates and moderators of future debates and forums to discuss key components of the Democratic National Committee's platform; and

BE IT FURTHER RESOLVED, that the Democratic National Committee members encourage future discussions to be conducted according to the following rules:

1. The discussion should be about specific quotes from our party platform and the nature of the legislation needed to fulfill each platform pledge.
2. Each candidate should be given an equal amount of time to speak, with the allotment determined by dividing the length of the discussion by the number of candidates involved and rounding up to the nearest full minute.
3. Only one candidate's microphone should be active at a time.
4. Each time a candidate takes a turn speaking, they should be able to speak for as long or as briefly as desired, providing they have time remaining.
5. Once a candidate has used all of their allotted time, their microphone should no longer be activated.
6. Monitors should be provided to candidates so that they can see the amount of time remaining for themselves and other candidates to speak and the candidates in the queue to speak.
7. Candidates should be encouraged to focus their remarks on statements from our party platform, with the intention of making it clear what legislation drawn from our platform (implicitly or explicitly) they support and what changes in our platform they would like to see.

Resolution Encouraging Congress to Enact President Franklin D. Roosevelt's Economic Bill of Rights

WHEREAS, January 11, 2019 marked the 75th anniversary of President Franklin D. Roosevelt's 1944 State of the Union Address which included his call for a second Bill of Rights; and

WHEREAS, those rights, as enumerated by President Roosevelt, included:

- The right to a useful and remunerative job in the industries or shops or farms or mines of the Nation;
- The right to earn enough to provide adequate food and clothing and recreation;
- The right of every farmer to raise and sell his products at a return which will give him and his family a decent living;
- The right of every businessman, large and small, to trade in an atmosphere of freedom from unfair competition and domination by monopolies at home or abroad;
- The right of every family to a decent home;
- The right to adequate medical care and the opportunity to achieve and enjoy good health;
- The right to adequate protection from the economic fears of old age, sickness, accident, and unemployment;
- The right to a good education; and

WHEREAS, President Roosevelt called upon "Congress to explore the means for implementing this economic bill of rights - for it is definitely the responsibility of the Congress so to do."; and

WHEREAS, seventy-five years later, Congress has yet to fulfill that responsibility; and

WHEREAS, millions upon millions of our fellow Americans have suffered, and continue to suffer, needlessly as a result of the failure of Congress to enact an Economic Bill of Rights.

WHEREAS, the 2016 Democratic Party Platform says that:

- “We are committed to doing everything we can to build a full employment economy, where everyone has a job that pays enough to raise a family and live in dignity with a sense of purpose.”
- “Democrats believe that climate change poses a real and urgent threat to our economy, our national security, and our children’s health and futures, and that Americans deserve the jobs and security that come from becoming the clean energy superpower of the 21st century.”
- “Democrats reject the notion that we have to choose between protecting our planet and creating good-paying jobs. We can and we will do both.”
- “Democrats believe that health care is a right, not a privilege, and our health care system should put people before profits.”

ensure that every American can retire with dignity, and protection of family farmers and small business owners from unfair competition; and

WHEREAS, U.S. officials at the United Nations are allegedly pressuring the U.N.'s Third Committee, which focuses on “social, humanitarian and cultural” rights, to revise their human rights documents, and replace the word “gender” with “sex” in all instances where it occurs; and,

WHEREAS, assigning a female/male binary sex at birth implicitly denies the very existence of intersex, transgender, and non-binary people, that there are over a dozen anomalies of the sex chromosomes and hormones existing outside of an XX/XY binary, complicating determination of sex at birth and specific health needs: medical, surgical, hormonal, and mental health; and,

WHEREAS, Trump administration efforts to legislate and edit transgender, intersex, and non-binary persons out of existence is the first step in denying the existence of said persons, leaving them without constitutional, civil, or human rights, and fair game to violence that far too often ends in death; and,

WHEREAS, the National Center for Biotechnology Information (NCBI) reports that LGBTQ+ young adults are disproportionately at risk for experiencing distress and abuse, and the Williams Institute, UCLA School of Law, reports transgender persons suffering rejection by family and friends, discrimination, victimization, or violence have a significantly higher rate of suicide attempts; and,

WHEREAS, subsequent to the leaking of a Trump administration memo arguing that transgender persons do not exist, calls to the Trans Lifeline, the only suicide hotline for trans people operated by trans people, received four times its average number of calls, and two times the average number of first-time callers contemplating suicide.

WHEREAS, the Democratic Party Platform States that “We will oppose all state efforts to discriminate against LGBT individuals, including legislation that restricts the right to access public spaces.”

WHEREAS, the Democratic Party Platform States that “We support a progressive vision of religious freedom that respects pluralism and rejects the misuse of religion to discriminate.”

WHEREAS, the Democratic Party Platform States that “We will support LGBT elders, ensure access to necessary health care, and protect LGBT people from violence—including ending the crisis of violence against transgender Americans.”

THEREFORE, BE IT RESOLVED:

Section 1: The Democratic Party re-commits to legislation protecting and defending the rights, safety, health, welfare, and existence of all transgender, intersex, and non-binary residents of, and visitors to, these United States; and,

Section 2: No person, church, religion, political organization, legislator(s), business, corporate entity, or private entity has the right to abrogate the rights of transgender, intersex, and non-binary persons or to deny their existence; and,

Section 3: We Democrats demand that the elected Democratic Congresspersons in the United States House of Representatives take immediate action and turn this resolution regarding faith-based Discrimination Against LGBTQ+ Community” into legislation and law, thwarting “religious freedom” attacks on transgender, intersex, and non-binary persons.

Recognizing the 40th Anniversary of the Taiwan Relations Act: An Enduring Partnership

WHEREAS, 2019 marks the 40th anniversary of the enactment of the Taiwan Relations Act, codifying into law the basis for continued commercial, cultural, and other relations between the United States and Taiwan; and

WHEREAS, the Taiwan Relations Act has served as an anchor for maintaining peace, security, and stability in the Taiwan Strait, played a key part in preserving Taiwan's freedom and democracy and is in the national interest of the U.S.; and

WHEREAS, the Taiwan Relations Act states that it is the policy of the U.S. to provide Taiwan with arms of a defensive character to maintain the capacity to resist any resort to force or other forms of coercion; and

WHEREAS, the U.S.-Taiwan relationship has been reinforced as follows

- (1) Taiwan has flourished to become a free society, a beacon of democracy in the Indo-Pacific, and an important trading partner of the U.S.;
- (2) Taiwan became the first in Asia to legalize same-sex marriage, a landmark achievement for LGBTQ rights;
- (3) Taiwan is committed to addressing climate change by implementing stepwise reduction of greenhouse gas emissions in the coming years;
- (4) The U.S and Taiwan are both committed to defending shared values and common interests, including freedom, democracy, human rights, the rule of law, and diversity;
- (5) The U.S. and Taiwan have launched the Indo-Pacific Democratic Governance Consultation in 2019. Taiwan's collaboration with the U.S.

supports religious freedom, and combats global terrorism and disinformation, as demonstrated by its participation in the Global Coalition to Defeat ISIS and cooperation under the Global Cooperation Training Framework (GCTF);

- (6) The U.S. is the 2nd largest trading partner and foreign investor of Taiwan while Taiwan is the 11th largest trading goods partner of the U.S. and the 89th largest export market for U.S. agricultural products. The bilateral trade and investment has created more than 370,000 jobs in the U.S., and a Bilateral Trade Agreement (BTA) will further enhance this relationship;

THEREFORE, BE IT RESOLVED, (1) that the Democratic National Committee reaffirms our unwavering commitment to the Taiwan Relations Act, as the cornerstone of relations between the U.S. and Taiwan, and our support for Taiwan's freedom, open society and democratic institutions; (2) that the DNC supports Taiwan's meaningful participation in the World Health Organization (WHO), the International Civil Aviation Organization (ICAO), and the UN Framework Convention on Climate Change (UNFCCC), as well as other international organizations; (3) that the DNC recognizes Taiwan as a vital, constructive and reliable partner in Asia, and supports deepening the friendship between our two peoples, through a BTA.

WHEREAS, James Barton King was born on March 27, 1935 in the Pioneer Valley mill town of Ludlow, Massachusetts where he was raised; and

WHEREAS, in 1953 he enlisted in the army and served his country as a paratrooper in the 11th and 187th Airborne Division during the Korean War; and

WHEREAS, upon returning, he finished high school and through the GI Bill graduated from American International College in Springfield, MA; and

WHEREAS, as a 7th grade social studies teacher at Ludlow Junior High, he learned to love teaching and never stopped; and

WHEREAS, he volunteered for Senator John F. Kennedy's 1952 senate campaign, which began his lifelong work on hundreds of political campaigns throughout the country and world; and

WHEREAS, Representative Richard E. Neal said "Jim King was one of the best Democratic political operatives in the business. He was a legendary figure in local, state and national politics for more than a half century"; and

WHEREAS, he worked extensively on the presidential campaign of Robert F. Kennedy and advanced his famous speech in Indianapolis on April 4, 1968, following the assassination of Martin Luther King Jr.; and

WHEREAS, while campaigning for JFK, Jim accompanied a young Edward M. Kennedy to his first factory gate and later served from 1967 to 1975 as special assistant and advance man to the Senator, whose travel brought Jim to all corners of the globe and to every city and town in Massachusetts; and

WHEREAS, Jim traveled extensively and met with many world leaders, but he never took them, or himself, too seriously. His legendary humor was even able to bring Soviet leader Leonid Brezhnev to uncontrolled laughter; and

WHEREAS, Democratic National Committee Chair Paul G. Kirk said “he set the 'gold standard' as an advance man and an outstanding public servant. He embodied that same standard as a human being for the very same reasons. He was a force for goodness in all he accomplished by the example he set in treating every person he met with decency, respect, good humor and genuine warmth”; and

WHEREAS, in 1977 he was appointed by President Jimmy Carter to the National Transportation Safety Board where he served as Chair until 1982. At the NTSB he championed many safety improvements including reducing toxic gases from burning aircraft upholstery and mandating a railroad tanker car safety device, which saved many lives; and

WHEREAS, President Carter said, “Jim dedicated his life to public service, and his tireless work for the public good was coupled with a delightful sense of humor and a zest for life”; and

WHEREAS, he ran the podium operation at six Democratic National Conventions; and

WHEREAS, Secretary John Kerry, for whom Jim worked as Chief of Staff in his Senate office, said “If you saw Jim King on the podium managing things, you knew it was going to work out and you didn’t have to worry. He took the worry and the concern away and he launched an awful lot of careers off that podium along the way”; and

WHEREAS, he was appointed Director of the U.S. Office of Personnel Management in 1993 by President Clinton where he ensured that all federal workers were treated fairly and with respect regardless of their position; and

WHEREAS, his work with the National Democratic Institute brought him to countries around the world where he helped them develop their own democratic institutions. In retirement, he was a proud member of Northern Ireland’s Experts Panel and his ideas contributed in a small way to the creation of a government for Northern Ireland in which unionists and nationalists shared power; and

WHEREAS, in retirement, he never slowed down, volunteering until the end, working to help the elderly, the homeless and the forgotten. In his life, he brought a smile to the faces of thousands and helped improve the lives of many more; and

WHEREAS, on June 9, 2019, Jim King passed away at the age of 84 at his home in Rockport, Massachusetts; and

WHEREAS, the spirit of Jim King lives on with his wife Eleanor and their five children, their spouses, ten grandchildren, his sister Almeda, and all those he inspired throughout a lifetime of public service;

WHEREAS, on June 16, 2019, Dr. Frank LaMere, Manape Huk ga “Soldier Chief,” was called to the Creator, leaving a legacy of service and strength;
